- 02 Make booking with airlines.
- 03 Must agree to accept shipment before booking can be confirmed.
- 04 Consignee can engage Amber to do clearance. (e.g. Custom clearance and quarantine clearance).
- 05 Consignee or its agent must produce the original Import Permit for clearance.



Required dimensions for animal transportation




Airline Travel Cage Sizing Chart

Please Measure as follows:

- A. From the tip of the nose to the base of the tail
- B. The height from the floor to the top of the head
- not including the ears
- C. From the floor to the elbow
- D. The width across the body at the widest point
- Normally, the shoulders

The animal must be able to turn about normally while standing, stand, sit erect and lie in a natural position.



Packing/Cage/ Pets Travel Crate Requirements (IATA Pets Travel Rules)

A Brief Story About Market Affirmation

It's a market testing stage to ensure that the products produced by the company can be accepted and effectively used by the broad market. For start-up companies, we can use data already achieved by similar products from other companies.

Cage must be suitable for the pets. For example, pets must have enough space to turn about, stand, and sit erect, and lie down in a natural position.

Water container must be present within the container with outside access for refilling.

Food containers must be present either within the container, if sealed or attached to it, in case of any flight delay.

Pets Cut off time/Pets Arrival Time at KLIA Airport

At least Four (4) to Five (5) hours before/ prior to flight departure.

* Please refer to RF Pets for any changes in quarantine requirements by the importing/ destinations countries.



KLIA Animal Quarantine Stations operational hours; 8:00am to 17:00pm only.

The Department of Veterinary Services, KLIA Animal Quarantine Stations request that clients book their animals on flights arriving in KLIA between the hours of 8:00am and 17:00pm. It is a very suitable time for the KLIA Animal Quarantine to facilitate the boarding and physical examination of the animals during day time. Please take note, due to recent mortality case of a dog that arrived after midnight, our Chief Senior Assistant Director, Biosecurity and SPS Management Division, Dr. Norlizan b. Md. Noor have granted the approval of KLIA Animal Quarantine operational hours, between 8:00am and 17:00pm only. This new rule and regulation takes effect starting on 1st July 2012.
